Official Show Rules

1. This show is held in strict accordance with the latest and revised Official Show Rules of the American Rabbit Breeders Association, Inc. There will be **2 ARBA Sanctioned shows** and **1 Non-ARBA Sanctioned show** held concurrently.
2. All animals must be healthy and in proper-size transport cages to ensure rabbits' well-being. Show officials and/or judges observing a rabbit with obvious signs of disease will be **eliminate** from competition and the exhibitor **must remove** the rabbit from the show room
3. Rabbit(s) will be with the owner at all times **except** during judging that the rabbits must be placed in judging coops/cages. Exhibitors are responsible to make sure their rabbits are taken to the judging area when called. Absolutely no refund of entry fees will be made.
4. The Organizer and/or its officers are not liable for any injury or damage in connection with the show.
5. Exhibitors should completed the entry form and post/mail to this address **Lot 116, Jln Sg. Buloh, Taman Segar, Kg. Subang, 40150 Shah Alam, Selangor** by **15th May 2011**. **RM 10 Administrative charges** will be levied for **late entries**.
6. Contact show superintendent for breed/variety/class if not sure. **No substitutions** on the day of the show, except within the same breed, sex, age and variety.
7. **One exhibitor for one entry**. Extra entry forms may be photocopied as needed.
8. Exhibitor(s) who **act unruly and disrupt** the show will be asked to leave the show and their rabbit(s) will be disqualified without refund or compensation. Exhibitor(s) should **follow the rule governed by Pet World Malaysia**. No smoking in buildings, no alcoholic beverages allowed on the show premise.
9. Awards must be **picked up after the show** and it is the **responsibility** of the exhibitor to bring remark cards to the secretary's table at the conclusion of the show in order to receive ribbons.
10. **Parents - children must be under the supervision of an adult at all times**.

Judge's Profile

Show A by Randy Shumaker, ARBA Rabbit and Cavy Judge #666, Tollhouse, California, USA

- Randy Shumaker was born and raised in Indiana. For over fifteen years, Randy has been a licensed ARBA rabbit judge. In the 1990s, he also gained his ARBA judge license for cavies. Randy has judged all over the United States, Canada, Bermuda and three times in Japan. He has five times been nationally voted to judge Best In Show at ARBA Conventions. He served on the executive committee of two highly successful ARBA Conventions on California. From 2002 to 2006, Randy served as the Vice President of the American Rabbit Breeders Association. President of the American Satin Rabbit Breeders Association, director of the Holland Lop Rabbit Club, and Chairman of the ARBA Judge Licensing Committee and ARBA Airline Committee include some of his other commitments in the rabbit and cavy hobby. In 2008, he was awarded the President's Awards from ARBA President Dr. Chris Hayhow for his years of service to the ARBA.

Show B by Allen Mesick, ARBA Rabbit Judge #854, Tollhouse, California, USA

- Allen Mesick has been an active rabbit breeder since his youth. In 2001, Allen became a Registrar and was named the "ARBA King". American Fuzzy Lops were his first breed, and at the 2002 ARBA Convention, Allen's Fuzzy Lops won Best and Best Opposite Sex of Breed at the ARBA Convention. In 2003, Allen also won Best of Breed American Fuzzy Lop at the ARBA Convention. Currently, Allen raises Netherland Dwarfs and Mini Rex with Randy Shumaker. In 2010, Allen and Randy's Black Otter Netherland Dwarf "Paralyzer" won 10 Best In Shows, an accomplishment few rabbits ever reach. Aside from these two breeds, Allen raises Tans. At the 2007 ARBA Convention in Grand Rapids, Michigan, Allen won Best of Breed with a Black Junior Doe named "Rhea".
- In 2007, Allen received his ARBA Judge license. He has judged all over the United States and once in Canada. The Yokohama Bay Rabbit Club in Japan invited Allen to judge in 2007. Although Allen had been a judge for just two years, he was nationally selected as the Youth Best In Show Judge at the 2009 ARBA Convention in San Diego, California.

Please bring along your rabbit's 3 generations pedigree. A fee of USD 6 will be charged for each registration to be paid directly to the registrar.

- ARBA Recognized Breeds (Two(2) ARBA Sanctioned Show)
 - To be judged against current working Standard of Perfection (SOP). Rabbits may be without pedigree. Ear tattoo # is required. Only registered rabbits with full pedigrees can be awarded Grand Champion (3 GC Legs under 3 different judges). GC Legs can only be earned in the presence of at least 3 breeders/exhibitors AND at least 5 rabbits shown in each category/variety.

 - Local/Mixed/Neutered

Severability: The undersigned further expressly agrees that the foregoing Waiver and Assumption of risk Agreement is intended to be as broad and inclusive as is permitted by the law of Malaysia and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

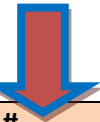
